Campus Planning Committee Annual Report 2019-2020

Summary of Meetings and Activities

Since Fall 2019, the Campus Planning Committee (CPC) has held 14 meetings and forwarded 11 recommendations to Administration. The committee reviewed numerous designs for campus development projects including the Zebrafish International Resource Center (ZIRC) Research Restoration and Expansion, the Tykeson Hall Lawn Project, the Hamilton and Walton Residence Halls Transformation Project – Phase Two post-schematic design refinement, and a number of smaller capital improvement projects. In 2019, the CPC began the long process of providing feedback for the Campus Plan Amendment North of Franklin Boulevard. This process consisted of six committee meetings, and is anticipated to culminate at the end of 2020 with the committee taking action. Additionally, it reviewed the City of Eugene's plans for the Franklin Boulevard Transformation Project preferred design alternative.

CPC members participated in the architect selection process for development projects that were initiated this past year and served on numerous project user groups. Staff educated the committee about its role in the campus development process and provided relevant background materials to enable well-informed decisions about a wide range of complex campus planning and development issues.
