1. Knight Campus - Update

<u>Background:</u> The purpose of this agenda item is to provide an update on the progress of the Knight Campus Project.

Action: No formal action is requested.

2. Campus Plan Oregon Model for Sustainable Development (OMSD) Amendment - Public Hearing and Action

<u>Background:</u> The purpose of this agenda item is to hold a public hearing and review the proposed amendments to the Campus Plan Oregon Model for Sustainable Development (OMSD).

As defined in the Campus Plan (p. 22) a public hearing is required when Campus Plan amendments are proposed. Notice of the public hearing and other opportunities for input were provided as required by the Campus Plan.

The amendments to the Campus Plan affect Policy 10: Sustainable Development. Please

The CPC held an initial discussion about the proposed amendments on May 4, 2018. The following is a compiled list of member's comments:

 Consider ways of demonstrating that other aspects covered by the LEED certification process (besides energy, water, and people-related strategies) are being addressed whether or not a development project is required to go through the formal LEED certification.

The CPC held a follow-up discussion about the proposed amendments on May 4, 2018. The following is a compiled list of member's comments:

- There have been times during the course of a project where LEED certification feels like chasing points or percentages, so it is great to make changes that make the program thoroughly sustainable.
- Focus on designing high-performance envelopes and passive systems rather than trying to make mechanical systems more efficient.

The CPC held another follow-up discussion about proposed amendments to the OMSD on May 15, 2018. The following is a compiled list of member's comments:

- Consider enhancing elements related to the natural environment as part of the future North Campus Plan amendment process.
- Continue to balance (sometimes competing) interests e.g. lighting at night for safety vs dark night sky considerations for wildlife and birds.
- Consider addressing the design of bird-friendly buildings in the future.
- If new text related to the natural environment is added in the future, be careful to ensure that existing natural spaces are protected, but that existing landscaped spaces are not required to revert to a natural state.
- Be careful not to assume that areas on campus that appear natural are actually natural - for example the area along the riverfront in north campus may actually require restoration rather than preservation in its current state.

In reference to the latter comments, please refer to the attachments for a summary of excerpts from existing Campus Plan language related to natural spaces and wildlife on campus.

Following the public hearing, the Campus Planning Committee will be asked to complete its review of the proposed amendments, taking into consideration all input provided by interested parties. It will forward a recommendation to the university president, who will have final approval authority.
