1. Next Generation Housing Development Plan & East Campus Plan Update - Check-in

<u>Background:</u> The purpose of this agenda item is to check-in regarding the Next Generation Housing Development Plan & East Campus Plan update.

Over the next 20 years, the University of Oregon is planning more high-quality, learning-centered residential communities on campus to serve our growing student community, including first-year students, upper-division undergraduates, graduates, and families. On-campus housing improves student performance, reduces academic costs, adds to the overall housing supply, and intentionally connects and engages students with the University of Oregon. The outcome of this work will include a long-range plan for housing and infrastructure and an update to the 2003 Development Policy for the East Campus Area (East Campus Plan).

2. Next Generation Housing New Residence Hall Project - Meeting One

<u>Background:</u> The purpose of this agenda item is to hold Meeting One for the Next Generation Housing New Residence Hall Project.

As described in the attached project description, two new residence halls will be constructed to meet current and anticipated demand for student housing on campus. Phase 1 will be complete by Fall 2027. Phase 2 will be complete by Fall 2028. The proposed project is Informed by the Next Generation Housing Development Plan. Phase 2 requires additional time to complete land use changes and will be brought to the CPC for Meeting One for site selection at a subsequent meeting.

As part of Meeting One (further described in the *Campus Plan* on page 27), the committee is asked to complete the following tasks:

- <u>Site Selection (Phase 1)</u> Review the preferred site and make a site recommendation. (Phase 2 site selection will be brought to the committee at a subsequent meeting).
- <u>User Group</u> Review the proposed user group representation and provide comments to the CPC chair, who appoints group members (refer to page 28 of the *Campus Plan* for more information about user groups). It is intended the same User Group will guide both Phase 1 and Phase 2 of the project.
- <u>Key Principles and Patterns</u> Identify key principles, patterns, and other relevant campus design issues from the *Campus Plan*.
- Other Campus-wide Opportunities Identify potential opportunities to address campus-wide needs within the subject area or opportunities to cooperate with other nearby development efforts.

Following Meeting One and final approval from the president, the project's User Group will be established and will consider the identified key principles, patterns, and issues during the project design process.
