1. *Campus Plan* Outdoor Sign Plan – Proposal for Banner at the Museum of Natural and Cultural History (MNCH)

Background: The purpose of this agenda item is to review the proposal to establish an approved banner location at the Museum of Natural and Cultural History (MNCH).

As described in the attached description, The Museum of Natural and Cultural History is proposing a banner location at the north entrance into the entrance courtyard along 15th Avenue that will be consistently used for displaying banners. This proposal includes a land acknowledgment intended to be displayed for at least one-year. Future banners related to the MNCH could be installed in the future.

All proposals for exterior signage not covered by the campus standard designs shall be reviewed according to the criteria stated in the Campus Outdoor Sign Plan and approved on a case-by-case basis in a manner authorized by the Campus Planning Committee (with exceptions noted in the plan).
