1. Senate Bill 554 Signage

Background: The University Policy, Firearms, numbered IV.05.05 was recently updated with changes allowed under Oregon Senate Bill 554 (2021) to clarify the university prohibits all individuals from possessing or using firearms on university-owned or –controlled property, except as allowed within the Policy. SB 554 requires signage at “all normal points of entry to the school grounds” indicating a valid concealed carry permit does not authorize an individual to carry a concealed weapon.

State law prohibits the possession of a firearm while in or on a public building, including a college or university, unless an exception applies. One exception is when the carrier of the firearm holds a concealed carry permit. The university has enacted policy authorized within SB 554 that removes the exception for concealed carry permit holders while in or on buildings or university grounds.

The attached diagrams illustrate proposed locations and signs.

All proposals for exterior signage not covered by the campus standard designs shall be reviewed according to the criteria stated in the Campus Outdoor Sign Plan and approved on a case-by-case basis in a manner authorized by the Campus Planning Committee (with exceptions noted in the plan).

2. UO Long Range Transportation Plan – Update and Discussion

Background: The purpose of this agenda item is to discuss and provide feedback on the UO Long Range Transportation Plan.

Transportation Services recently contracted with a transportation consultant team to begin work on a long-range Transportation Plan for the University of Oregon. Because Transportation Services oversees transportation programs, policies, and most travel infrastructure on campus, they have taken the lead in this effort, while in very close coordination with Campus Planning and Facilities Management (CPFM). The Plan is a comprehensive long-term strategy aimed at enhancing accessibility, fostering campus vibrancy, and promoting sustainable travel options including walking, biking, and transit use. The goal is to support safe and efficient travel needs while effectively coordinating development efforts with the surrounding community. The UO Transportation Plan will provide the university a long-range transportation capital project list, sustainable travel options, programs, and services that help campus meet its sustainability goals while best meeting the travel challenges and opportunities of tomorrow. This planning process continues to solicit input, feedback, and ideas from the UO community, including from the Campus Planning Committee through this first input session.
