2. Next Generation Housing New Residence Hall Project - Conceptual Design Update

<u>Background:</u> The purpose of this agenda item is to share an update regarding the conceptual design of the Next Generation Housing New Residence Hall Project.

Two new residence halls will be constructed to meet current and anticipated demand for student housing on campus. Phase 1 will be complete by Fall 2027. Phase 2 will be complete by Fall 2028. This project is informed by the Next Generation Housing Development Plan.

3. East Campus Plan Update and Campus Plan Amendment - Check-in

<u>Background:</u> The purpose of this agenda item is to check-in regarding the *East Campus Plan* update and proposed *Campus Plan* amendment.

Over the next 20 years, the University of Oregon is planning more high-quality, learning-centered residential communities on campus to serve our growing student community, including first-year students, upper-division undergraduates, graduates, and families. Oncampus housing improves student performance, reduces academic costs, adds to the overall housing supply, and intentionally connects and engages students with the University of Oregon. The outcome of this work will include a long-range plan for housing and infrastructure and an update to the 2003 Development Policy for the East Campus Area (*East Campus Plan*).

4. 13th Avenue Redesign - Schematic Design Review

<u>Background:</u> The purpose of this agenda item is to review the schematic design for the 13th Avenue Redesign project.

As shown in the attached description, the schematic design addresses the half-mile segment of 13th Avenue between Kincaid Street and Agate Street, along with key campus entrances at 13th Avenue and Kincaid Street and 13th Avenue and Agate Street.

The project is informed by the Conceptual Design completed in August 2019 led by Walker Macy Landscape Architects. Additional information about the concept design can be found at: https://cpfm.uoregon.edu/13th-avenue-axis-conceptual-design

The schematic design establishes a design that will transform 13th Avenue into an exceptional pedestrian walking and bicycling experience on the university's primary east-west axis while still allowing limited vehicle access for service and emergencies. The design addresses circulation for all modes, stormwater treatment, street trees, lighting, seating, campus gateways, service vehicles, paving, etc.

The project is only funded through schematic design.
